

Strongly bound states of hydrogen in intense magnetic field*

The authors derive asymptotic formulas for the energies of the strongly bound states of hydrogen for large magnetic fields. Rigorous lower bounds on the binding and also upper bounds are given based on generous estimates of the errors. Comparison with variational and other previous numerical results shows their tendency to underestimate the binding.

I. INTRODUCTION

Intense (sometimes called "superstrong") magnetic fields are characterized by Landau orbits which are of the same order as, or smaller than, the Bohr radius. This is the case for $B \sim 3 \times 10^9$ G. Such fields are believed to pervade the surfaces of certain neutron and magnetic stars.¹ They make spectroscopic and other properties of matter very different from the ordinary. For the obvious reasons of abundance and theoretical tractability the spectral properties of hydrogen are of particular interest. There is also independent theoretical interest in the problem in the context of perturbation theory.²⁻⁴

The key to the large-field behavior is the (essentially) one-dimensional dynamics in the direction of B . (Schiff and Snyder realized this as early as 1939.⁵) Hence hydrogen in a large magnetic field is related to some form of the one-dimensional Coulomb (long-range) problem. A definite connection with the one-dimensional truncated Coulomb Hamiltonian [$V(x) = -1/(|x|+a)$] was suggested by Ruderman in 1971.⁶ This gave the leading term in the $B \rightarrow \infty$ expansion for the binding energy. However, the connection proposed by Ruderman was just a clever guess. It was not clear how seriously it should be taken, i.e., to what order it is accurate. (This question is answered by the present work.)

Much effort has been devoted to numerical analysis of the problem. Among the methods employed were variational,^{7,8} Padé approximations,⁹ numerical integration of differential equations,^{10,11} and Thomas-Fermi.²¹ Typically the various methods led to scattering of ~20% in their estimates.

Theoretically the problem was in two parts: first, to perform the Schiff-Snyder reduction to one dimension systematically; second, to find a gener-

al method for analyzing the one-dimensional Hamiltonian in the appropriate limit. It turns out that both problems are intimately related. Both can be solved by a theory of weak coupling recently developed by one of us.^{3,4}

Before explaining what weak coupling has to do with large magnetic fields let us explain what the strongly bound states are. The strongly bound states are those that increase their binding indefinitely with B . On each subspace, with fixed azimuthal quantum number m , the ground state is strongly bound. Heuristically this comes about by squashing the state onto the attractive Coulomb singularity. Ruderman found that this divergence of the binding is essentially logarithmic in B .

How is weak coupling related to high B ? This is a consequence of the scaling properties of the Hamiltonian¹⁷; Surmelian and O'Connell¹³ noted that with charge z the hydrogenlike Hamiltonian $H(B, z)$ satisfies

$$H(B, z) \cong BH(1, zB^{-1/2}) \quad (1.1)$$

(\cong denotes unitary equivalence). Hereafter we use λ for z . It follows that $B \rightarrow \infty$ corresponds to $\lambda \rightarrow 0$. This is the weak coupling.

The paper is organized as follows. In Sec. II we derive weak coupling formulas and show that the one-dimensional Schiff-Snyder Hamiltonian is a first-order approximation in the weak coupling expansion. In Sec. III we evaluate explicitly the first few terms in the expansion for the Schiff-Snyder Hamiltonian. This yields asymptotic formulas for the binding energies for the ground states for arbitrary quantum numbers m . In Sec. IV we bound the first correction due to the latent two dimensions. Section V is numerical. We give generous upper and rigorous lower bounds for the binding energies. Comparison with other results is also made.

In Secs. II-IV, the unit of energy is 54.4 eV and the unit of magnetic field 9.4×10^9 G.

II. WEAK COUPLING

The Schrödinger equation for (spinless) hydrogen in a constant magnetic field \vec{B} (and infinitely heavy nucleus) is

$$H(B) = (\vec{p} - \frac{1}{2}\vec{B} \times \vec{r})^2 - 1/|\vec{r}|. \quad (2.1)$$

By (1.1), $H(B)$ is essentially equivalent to

$$\tilde{H}(\lambda) = (\vec{p} - \hat{z} \times \vec{r})^2 - \lambda/|\vec{r}|, \quad (2.2)$$

with \hat{z} a unit vector and

$$\lambda = (2/B)^{1/2}. \quad (2.3)$$

In each subspace, with azimuthal quantum number m , the continuous spectrum of (2.1) starts at $|B|(|m| - m + 1)$.¹⁴ The binding energy is the (positive) distance of the eigenvalue from the threshold of the continuous spectrum. An index m , which we shall drop as a rule, denotes the $L_z = m$ subspace. It is sufficient to consider $m \geq 0$, which we henceforth do. Let α^2 denote the binding energy of (2.2). The corresponding binding for (2.1) will be denoted by ϵ^2 . The two are related by

$$\epsilon^2 = \frac{1}{2}B\alpha^2. \quad (2.4)$$

Let

$$H_{2,m} = (\vec{p} - \hat{z} \times \vec{r})_m^2 - 2.$$

The eigenvalue problem (2.2) can be written

$$[1 - \lambda K(\alpha)]\varphi = 0, \quad (2.5)$$

where

$$K(\alpha) = (1/|\vec{r}|^{1/2})(H_2 + \alpha^2)^{-1}(1/|\vec{r}|^{1/2}), \quad (2.6)$$

$$\varphi = |\vec{r}|^{-1/2}\psi;$$

ψ is the usual bound-state wave function. Now

$$(H_2 + \alpha^2)^{-1} = |0\rangle\langle 0| \frac{e^{-\alpha|z-z'|}}{2\alpha} + \frac{1 - |0\rangle\langle 0|}{H_2 + \alpha^2}, \quad (2.7)$$

where $|0\rangle$ is the ground state of the two-dimensional Landau Hamiltonian restricted to the $L_z = m$ subspace. The first term on the right-hand side of (2.7) is singular in the limit $\alpha \rightarrow 0$. The second term, on the other hand, is uniformly bounded by $\frac{1}{4}$. Motivated by this and Ref. 4, we introduce a more elaborate decomposition. Let

$$L = \frac{1}{|\vec{r}|^{1/2}} \frac{1 - |0\rangle\langle 0|}{H_2 + \alpha^2} \frac{1}{|\vec{r}|^{1/2}},$$

$$P = \frac{1}{2} \frac{1}{|\vec{r}|^{1/2}} |0\rangle\langle 0| e^{-\alpha|z| - \alpha|z'|} \frac{1}{|\vec{r}|^{1/2}},$$

$$Q = \frac{1}{2} \frac{1}{|\vec{r}|^{1/2}} |0\rangle\langle 0| (e^{-\alpha|z-z'|} - e^{-\alpha|z+z'|})$$

$$\times \frac{\theta(zz')}{|\vec{r}|^{1/2}}, \quad (2.8)$$

and $\theta(x) = 1$ for $x \geq 0$ and zero otherwise. Then

$$K = P/\alpha + Q/\alpha + L. \quad (2.9)$$

By Appendix A

$$\|L\| \leq 3\pi/4\sqrt{2}. \quad (2.10)$$

Thus for $B \geq 6$ [B and λ related by (2.3)] $\lambda\|L\| < 1$. By direct variation calculation (see Appendix A) one can show that the ground state in the m subspace has binding that increases without limit as $B \rightarrow \infty$. In addition, it is shown that

$$\|Q\| \leq \sqrt{3}. \quad (2.11)$$

Consequently $(\lambda/\alpha)Q = (1/\epsilon)Q$ is arbitrarily small for sufficiently large B . Thus, as in the one-dimensional case,^{3,4} the key to the analysis is the realization that the most divergent part of K as $\alpha \rightarrow 0$ is rank 1.

Let B_c be so large (λ so small) that

$$\|\lambda L + (1/\epsilon)Q\| < 1 \quad (2.12)$$

for $B \geq B_c$. By Appendix A and the numerical results of Sec. IV, one finds $B_c \leq 300$.

Theorem 2.1: The eigenvalue equation for the ground state with binding ϵ^2 for $B \geq B_c$ is given by

$$\epsilon = \text{Tr}\{[1 - (1/\epsilon)Q - \lambda L]^{-1}P\}. \quad (2.13)$$

Proof: Since $[1 - (1/\epsilon)Q - (1/\lambda)L]\psi = 0$ implies $\psi = 0$ for $B \geq B_c$, (2.5) can be written

$$[1 - (1/\epsilon)A]\varphi = 0, \quad (2.14)$$

where

$$A \equiv [1 - (1/\epsilon)Q - \lambda L]^{-1}P.$$

A is a product of a bounded operator and a rank-1 operator. By standard arguments the eigenvalue problem (2.14) has the eigenvalue equation

$$\det[1 - (1/\epsilon)A] = 1 - (1/\epsilon)\text{Tr}(A) = 0, \quad (2.15)$$

since A is rank 1, Q.E.D.

A systematic expansion in the small parameters λ and $1/\epsilon$ follows from (2.15) by expanding the denominator in a power series to lower orders:

$$\epsilon = \text{Tr}(P) + (1/\epsilon)\text{Tr}(PQ) + (2/B)^{1/2}\text{Tr}(LP) \dots \quad (2.16)$$

In Sec. III we evaluate the first two traces (the leading behavior) and in Sec. IV we bound the third.

Setting $L = 0$ in (2.16) gives the eigenvalue equation for the ground state of the Schiff-Snyder Hamiltonian.

III. SCHIFF-SNYDER HAMILTONIAN

The Schiff-Snyder Hamiltonian \tilde{H}_S is

$$\tilde{H}_S^{(m)} = -\frac{d^2}{dx^2} - \lambda W_m(x), \quad (3.1)$$

where

$$W_m(x) \equiv \left\langle 0 \left| \frac{1}{|\vec{r}|} \right| 0 \right\rangle = \frac{1}{|m|!} \int_0^\infty \frac{e^{-t} t^{|m|} dt}{(t+x^2)^{1/2}}. \quad (3.2)$$

Proposition 3.1: The eigenvalues of $\tilde{H}_S^{(m)}(\lambda)$ are bounded from above by the eigenvalues of the one-dimensional truncated Coulomb Hamiltonian with potential

$$-\lambda/[|x| + (m+1)^{1/2}]$$

and

$$E_n^{\text{Hyd}} \leq E_{2n}^{\text{Schiff-Snyd}},$$

with E_n^{Hyd} the n th $L_x = 0$ hydrogenic energy (with $\lambda = e^2$).

Proof:

$$1/(m+1+x^2)^{1/2} \leq W_m(x) \leq 1/|x|. \quad (3.3)$$

The right-hand side of (3.3) follows directly from (3.2) and the left-hand side, which is also easy, is proved in Appendix C. It follows that $W_m(x) \geq [(m+1)^{1/2} + |x|]^{-1}$. This together with the min-max principle completes the proof of the first half of the proposition. For the second half, note that the one-dimensional Schrödinger equation with Dirichlet boundary conditions is identical to the radial wave equation with $l=0$. Q.E.D.

Corollary 3.2: Only the ground state of \tilde{H}_S is strongly bound in the sense that α/λ goes to infinity as $\lambda \rightarrow 0$.

Let α^2 be the binding energy for the ground state of \tilde{H}_S . Mimicking the derivation in Sec. II, we get

$$\alpha = \lambda \text{Tr}(P) + \frac{\lambda^2}{\alpha} \text{Tr}(PQ) + \frac{\lambda^3}{\alpha^2} \text{Tr}(PQ^2) + \dots, \quad (3.4)$$

where P and Q are as in (2.8). This is identical to (2.16), with λ and α related to B and ϵ by (2.3) and (2.4) and L set equal to zero. Now

$$\begin{aligned} \text{Tr}(P)_m &= \int_0^\infty e^{-2\alpha x} W_m(x) dx \\ &= \int_{2\alpha}^\infty \frac{e^{-x}}{x} dx + \int_0^1 (1-2\alpha x) W_m(x) dx \\ &\quad + \int_1^\infty e^{-2\alpha x} \left(W_m - \frac{1}{x} \right) dx + O(\alpha). \end{aligned} \quad (3.5)$$

Using the identities²⁴ [(3.7) follows from (3.8)]

$$\begin{aligned} \int_1^\infty \left(W_m(x) - \frac{1}{x} \right) dx \\ = \ln 2 - \frac{1}{m!} \int_0^\infty e^{-x} x^m \ln[1 + (1+x)^{1/2}] dx, \end{aligned} \quad (3.6)$$

$$\begin{aligned} \int_0^1 W_m(x) dx \\ = \frac{1}{m!} \int_0^\infty e^{-x} x^m \ln[1 + (1+x)^{1/2}] dx + \frac{1}{2}(\gamma - q_m), \end{aligned} \quad (3.7)$$

$$\int_0^\infty e^{-x} x^m \ln \frac{1}{x} dx = m! (\gamma - q_m), \quad (3.8)$$

$$q_m \equiv \sum_{i=1}^m \frac{1}{i}, \quad q_0 = 0,$$

$$\int_0^\infty [x W_m(x) - 1] dx = -(m + \frac{1}{2})/m!, \quad (3.9)$$

$$\int_{2\alpha}^\infty \frac{e^{-x}}{x} dx = -\gamma - \ln(2\alpha) - \sum_{n=1}^\infty (-1)^n \frac{(2\alpha)^n}{n(n!)},$$

with γ being Euler's constant, one gets

$$\text{Tr}(P) = \ln(1/\alpha) - \frac{1}{2}(\gamma + q_m) + 2\alpha(m + \frac{1}{2})/m! + O(\alpha). \quad (3.10)$$

For the next term

$$\begin{aligned} \text{Tr}(PQ)_m &= \frac{1}{2} \int_0^\infty dx dy W_m(x) e^{-\alpha x} W_m(y) e^{-\alpha y} \\ &\quad \times (e^{-\alpha|x-y|} - e^{-\alpha|x+y|}) \\ &= \int_0^\infty W_m(x) e^{-2\alpha x} dx \int_0^x dy W(y) \\ &\quad - \frac{1}{2} \left(\int_0^\infty e^{-2\alpha x} W_m(x) dx \right)^2 \\ &= \int_0^\infty W_m(x) e^{-2\alpha x} \int_0^x W_m(y) (1 - e^{-2\alpha y}) dy. \end{aligned} \quad (3.11)$$

It is easy to show (see below) that

$$0 \leq \text{Tr}(PQ) \leq \frac{1}{12} \pi^2.$$

Let

$$\varphi(x) = -\frac{1}{m!} \int_0^\infty \frac{e^{-t} t^m dt}{(4\alpha^2 t + x^2)^{1/2}}, \quad (3.12)$$

$$\xi(x) = \int_0^x (1 - e^{-y}) \varphi(y) dy, \quad (3.13)$$

$$\chi(x) = \int_0^x \frac{1 - e^{-y}}{y} dy, \quad (3.14)$$

$$\eta(x) = \xi(x) - \chi(x). \quad (3.15)$$

Then

$$\eta(x) = \int_0^x [t\varphi(t) - 1] dt + O(\alpha) \quad (3.16)$$

and

$$\begin{aligned} \text{Tr}(PQ) &= \int_0^\infty \frac{e^{-x} \chi(x)}{x} dx + \int_1^\infty \frac{e^{-x}}{x} \eta(x) \\ &\quad + \int_0^1 e^{-x} \left(\varphi - \frac{1}{x} \right) \chi(x) dx + \int_0^1 \frac{e^{-x}}{x} \eta(x) dx \\ &\quad + \int_0^1 \frac{e^{-x}}{x} \left(\varphi - \frac{1}{x} \right) \eta(x) dx + O(\alpha). \end{aligned} \quad (3.17)$$

These integrals are evaluated in Appendix B. The result is

$$\begin{aligned} \text{Tr}(PQ) = & \frac{\pi^2}{12} + \alpha \frac{(m + \frac{1}{2})!}{m!} \ln(\alpha^2) \\ & + \frac{(m + \frac{1}{2})!}{m!} D_m \alpha + \alpha f_m, \end{aligned} \quad (3.18)$$

where

$$D_m = q_{m+1/2} + 2 \ln(2) - 2 + \gamma - 2c_1, \quad (3.19)$$

$$c_1 = \int_0^\infty [y(y^2 + 1)^{-1/2} - 1] \ln y \, dy \approx 0.30685; \quad (3.20)$$

q_m is as in (3.8) (see Table I), f_m is the constant

$$f_m = \int_0^\infty \left(W_m(x) - \frac{1}{x} \right) dx \int_0^x dy [W_m(y) - 1]. \quad (3.21)$$

TABLE I. Constants D_m and q_m of Eqs. (3.18) and (3.19) computed for angular momenta m , $m = 0, 1, 2$.

m	$q_{m+1/2}$	D_m
0	$2(1 - \ln 2)$	$\gamma - 2C_1 = -0.03648$
1	$2(\frac{4}{3} - \ln 2)$	$\frac{2}{3} + \gamma - 2C_1 = 0.6302$

In Appendix C we prove

$$0 \leq f_m \leq 2(m+1)^{1/2}(1 - \ln 2). \quad (3.22)$$

We have made no attempt to evaluate f_m numerically. For the third-order term we have the upper bound

$$\begin{aligned} \text{Tr}(PQ^2) = & \int \int \int_{\substack{x_3 \geq 0 \\ x_1 \geq x_2 \geq 0}} W(x_1) W(x_2) W(x_3) e^{-\alpha x_1 - \alpha x_2} (e^{-\alpha|x_2 - x_3|} - e^{-\alpha|x_2 + x_3|}) (e^{-\alpha|x_3 - x_1|} - e^{-\alpha|x_3 + x_1|}) \\ = & \int \int \int_{x_1 \geq x_2 \geq x_3 \geq 0} dx_1 dx_2 dx_3 W(x_1) W(x_2) W(x_3) \\ & \times [\exp(-2\alpha x_1 - 2\alpha x_2) \sinh^2(\alpha x_3) + 2 \exp(-2\alpha x_1 - \alpha x_2 - \alpha x_3) \sinh(\alpha x_3) \sinh(\alpha x_2)]. \end{aligned} \quad (3.23)$$

By (3.3)

$$0 \leq \text{Tr}(PQ^2) \leq \int \int \int_{x_1 \geq x_2 \geq x_3} (x_1 x_2 x_3)^{-1} [e^{-2x_1 - 2x_2} \sinh^2(x_3) + 2e^{-2x_1 - x_2 - x_3} \sinh(x_2) \sinh(x_3)] \leq \frac{5}{16} \quad (3.24)$$

[use $e^{-x} \sinh(x) \leq x$].

Collecting these terms, we obtain an asymptotic implicit function for the ground-state eigenvalue for the Schiff-Snyder Hamiltonian:

$$\begin{aligned} \frac{\alpha_m}{\lambda} = & \ln \frac{1}{\alpha_m} - \frac{1}{2}(\gamma + q_m) + \frac{\pi^2 \lambda}{12 \alpha} + \lambda \ln(\alpha_m^2) \\ & + \frac{2\alpha(m + \frac{1}{2})!}{m!} + \frac{\lambda D_m(m + \frac{1}{2})!}{m!} + \text{error}. \end{aligned} \quad (3.25)$$

The error is roughly of the order of $\frac{5}{16}(\lambda/\alpha)^2$.

Strictly speaking, only the first three terms on the right-hand side of (3.25) are significant. α/λ is of the order of $\ln(1/\lambda)$, and so the error dominates the $\lambda \ln(\alpha^2)$ term and the two following terms for λ sufficiently small. The main reason why we retain these terms is that we have been able to compute them. We mention, however, that these are also the first terms that distinguish the Schiff-Snyder energy from the truncated Coulomb. Another reason for retaining the high-order terms is

that, in the range of interest, λ is not so small that these terms are dominated by the error term.

IV. ASYMPTOTIC FORMULA

A. Latent two dimensions

By (2.17) the lowest-order correction taking into account the two dimensions transverse to B is $(2/B)^{1/2} \text{Tr}(LP)$.

$$\begin{aligned} \text{Tr}(LP) = & \sum_{n=1}^{\infty} \int \frac{W_{n,0}(x) W_{0,n}(x')}{2(\alpha^2 + 4n)^{1/2}} \\ & \times \exp[-(\alpha^2 + 4n)^{1/2} |x - x'|] \\ = & \sum_{n=1}^{\infty} \left(\frac{\pi}{2}\right)^{1/2} \int \frac{|\hat{W}_{n,0}(p)|^2 dp}{p^2 + 4n + \alpha^2}, \end{aligned} \quad (4.1)$$

where

$$W_{n,0}(z) = e^{-\alpha|z|} \left\langle n \left| \frac{1}{|\hat{F}|} \right| 0 \right\rangle \quad (4.2)$$

and a caret denotes Fourier transform. Hence

$$\begin{aligned} \text{Tr}(LP) &\leq \sum_1^{\infty} \left(\frac{\pi}{2}\right)^{1/2} \int \frac{|\hat{W}_{n,0}(p)|^2}{p^2+4} dp \leq \left(\frac{\pi}{2}\right)^{1/2} \frac{1}{4} \sum_1^{\infty} \int |W_{n,0}(x)|^2 dx \\ &= \frac{1}{4} \left(\frac{\pi}{2}\right)^{1/2} \int_{-\infty}^{\infty} dx e^{-2|x|} \int_0^{\infty} dt \frac{e^{-t} t^m}{m!(t+x^2)} \leq \frac{1}{2} \left(\frac{\pi}{2}\right)^{3/2} \frac{(m-\frac{1}{2})!}{m!} \leq \pi. \end{aligned} \quad (4.3)$$

B. Main result

From (3.25), for the Schiff-Snyder one-dimensional Hamiltonian, (2.3), (2.4), and (4.3) we obtain the ground state of the Hamiltonian (2.1), which, for $B \geq B_c$, is given by the asymptotic formula

$$\begin{aligned} \epsilon_m &= \frac{1}{2} \ln \left(\frac{B}{\epsilon_m^2} \right) - \frac{1}{2} (\gamma + q_m + \ln 2) + \frac{\pi^2}{12\epsilon_m} \\ &\quad - \left(\frac{2}{B} \right)^{1/2} \ln \left(\frac{B}{2\epsilon_m^2} \right) + 2 \left(\frac{2}{B} \right)^{1/2} \epsilon_m \frac{(m+\frac{1}{2})!}{m!} \\ &\quad + \left(\frac{2}{B} \right)^{1/2} \frac{(m+\frac{1}{2})! D_m}{m!} + \text{error} \end{aligned} \quad (4.4)$$

[q_m and D_m are given in (3.8) and (3.19)]. The error is roughly

$$\text{Error} \sim \frac{\pi}{4} \ln^{-2} B + (2\pi^2/B)^{1/2}. \quad (4.5)$$

The first term is the "one-dimensional error" (3.24) and the second the "two-dimensional" (4.3).

For magnetic fields $B \leq 3000$, (4.3) dominates (3.24). (The converse holds for higher B .) It follows that by computing a few terms in (4.1) the numerical accuracy of (4.4) would improve substantially.

V. NUMERICAL RESULTS

The physically interesting range of intense magnetic fields is restricted to fields smaller than a few thousands in the 9.4×10^9 -G unit. In this range the relevant small parameters are not very small. Consequently the weak coupling expansion to the order given in Eq. (4.4) is only moderately accurate and the error terms, $B^{-1/2}$ and $\ln^{-2} B$ [see Eq. (4.5)], are not negligible. We shall describe the solutions of Eq. (4.4), discuss their accuracy, and compare the results to those of other works.

We denote the binding energy obtained by solving the implicit function E_m (4.4). We also consider shorter series of the weak coupling expansion. In particular, $E_m(2)$ denotes the binding energy for the weak coupling formula in which only the first two leading terms in the right-hand side of Eq. (4.4) are kept. The behavior of the sequence of numbers obtained as more terms in the series in Eq. (4.4)

are retained is an empirical measure of the accuracy of E_m . Since $E_m(3)$ turns out to be quite close to E_m , it seems that the distance between $E_m(2)$ and E_m should be an empirically safe estimate of the accuracy of E_m . E_m and $E_m(2)$ are given in Table II for $m=0, 1$ in units of 13.6 eV. [E_m turns to be insensitive to f_m within the range given in (3.22).] The table indicates only a 20% accuracy for $m=0$ and $B \sim 1000$. In Table I we have also given a rigorous lower bound on the binding which follows from the truncated Coulomb (Prop. 3.1). This bound is not expected to be optimal. The eigenvalues of the truncated Coulomb Hamiltonian are given by the zeros of a certain hypergeometric function^{15,16} (see Appendix E). These have been determined numerically to an accuracy better than 0.001.

Table III considers the $m=0$ ground state. The table contains results obtained by alternative methods in other works (Refs. 7, 8, 9, 11, 12, 19, 20, 22): a rigorous lower bound on the binding, and a generous upper bound. This table is also in units of 13.6 eV and 2.35×10^9 G (unlike the other sections of this work). The lower bound has been discussed above. The upper bound was obtained by taking the generous bounds (3.24), (4.3), and (D3) for $\text{Tr}(PQ^2)$, $\text{Tr}(LP)$, and $\text{Tr}(PQ)$ in (2.16).

A direct check on the accuracy of the method of weak coupling is presented in Table IV. The table compares α , the square root of the binding [in $(54.4 \text{ eV})^{1/2}$] for the truncated Coulomb obtained by weak coupling, with the exact results. The small coupling constant λ was chosen to correspond [see Eq. (2.3)] to $100 \leq B \leq 1000$. The weak coupling formula for the truncated Coulomb Hamiltonian is given in Eq. (E5) in Appendix E. In Appendix E the exact solution is also reviewed. Table IV provides an indirect method for estimating the accuracy of Eq. (4.4), 16% accuracy at $B \sim 100$ and 7% accuracy at $B \sim 1000$. This error is smaller than the two estimates of the error given above and it is possible that the extra two dimensions for the Zeeman Hamiltonian increase the error.

In conclusion it seems to us that Tables II and III provide a realistic estimate of E_m and its accuracy.

APPENDIX A

a . $\|L\|$. Since $H_2(1 - |0\rangle\langle 0|) \geq 4$ and $1/a \leq \frac{3}{2}(1/a+2)$ for $a \geq 2$, we have the operator identity

$$|L| \leq \frac{3}{2} \left(\frac{1}{|\vec{x}|^{1/2}} \right) (H_2 + 2)^{-1} \frac{1}{|\vec{x}|^{1/2}}. \quad (\text{A1})$$

Thus

$$\|L\| \leq \frac{3}{2} \|\vec{x}^{-1/2} (H_2 + 2)^{-1}\|^2 \leq \frac{3}{2} \|\vec{x}^{-1/2} |\vec{p}|^{-1/2}\|^2 \|(p^2)^{1/4} (H_2 + 2)^{-1/4}\|^2 \|(H_2 + 2)^{-1/4}\|^2 \leq \frac{3}{2} \pi/2^{3/2}. \quad (\text{A2})$$

The norm of the first term is $(\frac{1}{2}\pi)^{1/2}$, by Ref. 18. The others are elementary.

b . $\|Q\|$. Consider a unitarity-dilated Q in the z direction. As $\alpha \rightarrow 0$ it converges to (and is pointwise bounded by)

$$\begin{aligned} \tilde{Q}_0 &= \frac{1}{2} |z|^{-1/2} (e^{-|z-z'|} - e^{-|z+z'|}) |z'|^{-1/2} \\ &\quad \times \theta(zz') |0\rangle\langle 0|. \end{aligned} \quad (\text{A3})$$

Let

$$V_R(z) \equiv \begin{cases} |z|^{-1/2}, & |z| \leq R, \\ 0, & |z| > R, \end{cases} \quad (\text{A4})$$

$$V_\infty(z) \equiv |z|^{-1/2} - V_R(z), \quad (\text{A5})$$

$$A \equiv \frac{1}{2} (e^{-|z-z'|} - e^{-|z+z'|}) \theta(zz'). \quad (\text{A6})$$

Then

$$\|\tilde{Q}_0\| \leq \|V_R A V_R\| + 2 \|V_R A V_\infty\| + \|V_\infty A V_\infty\|; \quad (\text{A7})$$

now

$$\|V_\infty A V_\infty\| \leq 1/R, \quad (\text{A8})$$

$$\begin{aligned} \|V_\infty A V_R\|^2 &\leq \|V_\infty A V_R\|_{HS}^2 \\ &= \int_0^R dz \frac{\sinh^2(z)}{z} \int_R^\infty \frac{e^{-2x}}{x} dx. \end{aligned} \quad (\text{A9})$$

Since $\sinh x$ is convex

$$e^z - e^{-z} \leq (z/R) e^R, \quad 0 \leq z \leq R. \quad (\text{A10})$$

This gives

$$\|V_\infty A V_R\| \leq 1/4\sqrt{R}, \quad (\text{A11})$$

$$\begin{aligned} \|V_R A V_R\|^2 &\leq \|V_R A V_R\|_{HS}^2 \\ &= 2 \int_0^R dx \frac{e^{-2x}}{x} \int_0^x \frac{\sinh^2(y)}{y} dy \\ &\leq \frac{1}{2} \int_0^R e^{-2x} dx \int_0^x e^{2y} dy \leq \frac{1}{4} R. \end{aligned} \quad (\text{A12})$$

So finally

$$\|\tilde{Q}_0\| \leq 3/2\sqrt{R} + \frac{1}{2}\sqrt{R}, \quad R > 0. \quad (\text{A13})$$

(A13) is minimized by $R=3$:

$$\|\tilde{Q}_0\| \leq \sqrt{3}. \quad (\text{A14})$$

Lemma A.1: In each subspace with fixed m the ground state of (2.1) has binding energy $\epsilon_m^2(B)$, which diverges as $B \rightarrow \infty$.

Proof: Let β be the unique solution of the implicit function

$$\beta = 2\lambda(m+1)^{1/2} e^{2\beta} \epsilon_1(2\beta), \quad (\text{A15})$$

with $\epsilon_1(x)$ the exponential integral and $\lambda = (2/B)^{1/2}$. As $\lambda \rightarrow 0$,

$$\beta \sim 2\lambda(m+1)^{1/2} \ln(1/\lambda).$$

Now choose a trial wave function

$$\exp[-\beta|x|(m+1)^{-1/2}] |0\rangle_m \quad (\text{A16})$$

and let $\alpha = \lambda\epsilon$. Using (C3) and the min-max principle, we find

$$\alpha \geq \beta. \quad (\text{A17})$$

APPENDIX B

1. $\int_0^\infty [e^{-x}/x] \chi(x) dx$

Write $(1 - e^{-y})/y$ as a power series and integrate term by term. This gives²⁴

$$\begin{aligned} \int_0^\infty \frac{e^{-x}}{x} dx \int_0^x \frac{1 - e^{-y}}{y} dy \\ = 1 - \frac{1}{2^2} + \frac{1}{3^2} - \frac{1}{4^2} + \dots = \frac{\pi^2}{12}. \end{aligned} \quad (\text{B1})$$

2. $\int_0^\infty [t(1+t^2)^{-1/2} - 1] \ln t dt$

$$\begin{aligned} \int_0^\infty [t(1+t^2)^{-1/2} - 1] \ln t dt \\ = \int_0^1 [t(1+t^2)^{-1/2} - 1] \ln t dt \\ + \int_1^\infty [1 - (1+t^2)^{-1/2}] \frac{\ln t}{t^2} dt. \end{aligned} \quad (\text{B2})$$

Expand the square root by the binomial and integrate term by term. This gives

$$\begin{aligned} 1 - \frac{1}{2^2} - \frac{1}{2} \left(1 - \frac{1}{4^2}\right) + \frac{1 \times 3}{2 \times 4} \left(\frac{1}{3^2} - \frac{1}{6^2}\right) - \frac{1 \times 3 \times 5}{2 \times 4 \times 6} \\ \times \left(\frac{1}{5^2} - \frac{1}{8^2}\right) + \dots \\ \approx 0.30685\dots \end{aligned} \quad (\text{B3})$$

3. $\int_0^1 [e^{-x}/x] \eta(x) dx$

Write e^{-x}/x as an infinite series and integrate by parts. The series obtained is expressible in terms of the exponential integral. It gives

$$\begin{aligned} \int_0^1 \frac{e^{-x}}{x} \eta(x) dx = 2[\gamma + \epsilon_1(1)] \alpha \frac{(m + \frac{1}{2})!}{m!} \\ - \int_0^1 \ln[x\varphi(x) - 1] dx + O(\alpha). \end{aligned} \quad (\text{B4})$$

In (B4) a scaled version of (3.9) has been used. Now

$$\begin{aligned} \int_0^1 \frac{t \ln t}{(a^2 + t^2)^{1/2}} dt = a \ln a \int_0^{1/a} \frac{t dt}{(t^2 + 1)^{1/2}} + a \int_0^{1/a} \frac{t \ln t}{(t^2 + 1)^{1/2}} dt + a \int_0^{1/a} \ln t dt \\ + a \int_0^\infty [t(1+t^2)^{-1/2} - 1] \ln t dt + O(\alpha) \\ = -a \ln a - 1 - c_1 + O(\alpha), \end{aligned} \quad (\text{B5})$$

where c_1 is as in Eq. (3.20) above. It follows that

$$\int_0^1 x \ln x \varphi(x) dx = -2\alpha \ln(2\alpha) \frac{(m+\frac{1}{2})!}{m!} - \frac{\alpha}{m!} \int_0^\infty e^{-t} t^{m+1/2} \ln t dt - 1 + 2\alpha c_1 \frac{(m+\frac{1}{2})!}{m!} + O(\alpha). \tag{B6}$$

One can calculate $q_{m+1/2}$ exactly using formula 4.333 of Ref. (24) (p. 574):

$$-\gamma - q_{m-1/2} = \frac{\pi^{1/2}}{(m-\frac{1}{2})!} \left(-\frac{d}{da}\right)^m \frac{\gamma + \ln(4a)}{a^{1/2}} \Big|_{a=1}. \tag{B7}$$

$$4. \int_1^\infty e^{-x} / x dx \int_0^x [y\varphi(y) - 1] dy$$

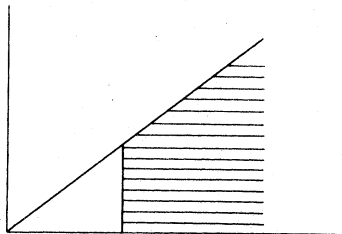


FIG. 1. Domain of integration for the double integral in Eq. (B8).

The domain of integration is as in Fig. 1. Since $|y\varphi(y) - 1| \leq \text{const} \alpha^2 / y^2$,

$$\int_1^\infty \frac{e^{-x}}{x} dx \int_0^x [y\varphi(y) - 1] dy = \int_1^\infty \frac{e^{-x}}{x} dx \int_0^1 [y\varphi(y) - 1] dy + O(\alpha) = -2\alpha \epsilon_1(1) (m+\frac{1}{2})! / m! + O(\alpha). \tag{B8}$$

$$5. \int_0^1 e^{-x} [\varphi(x) - 1/x] \chi(x) dx$$

Expanding χ in power series and integrating, we get

$$\int_0^1 e^{-x} \left(\varphi(x) - \frac{1}{x}\right) \chi(x) dx = \int_0^1 [x\varphi(x) - 1] dx + O(\alpha) = -2\alpha \frac{(m+\frac{1}{2})!}{m!}. \tag{B9}$$

$$f_m \leq \int_0^\infty \left((m+1+x^2)^{-1/2} - \frac{1}{x} \right) dx \int_0^x dy [y(m+1+y^2)^{-1/2} - 1] = (m+1)^{1/2} \int_0^\infty \left((1+x^2)^{-1/2} - \frac{1}{x} \right) [(1+x^2)^{1/2} - x - 1] dx = 2(m+1)^{1/2} (1 - \ln 2). \tag{C4}$$

$$6. \int_0^1 e^{-x} [\varphi(x) - 1/x] \eta(x) dx$$

$$\int_0^1 e^{-x} \left(\varphi(x) - \frac{1}{x}\right) \eta(x) dx = \int_0^1 \left(\varphi(x) - \frac{1}{x}\right) dx \int_0^x [y\varphi(y) - 1] dy + O(\alpha), \alpha \int_0^{1/\alpha} \left(W - \frac{1}{x}\right) dx \int_0^x [yW(y) - 1] dy + O(\alpha) = \alpha \int_0^\infty \left(W(x) - \frac{1}{x}\right) dx \int_0^x [yW(y) - 1] dy + O(\alpha). \tag{B10}$$

APPENDIX C

1. Lower bound for W_m

$(1/m!)e^{-t} t^m dt$ is a probability measure and $\langle t \rangle = m+1$. For fixed x , $(t+x^2)^{-1/2}$ is concave. By Jensen inequality

$$\langle (t+x^2)^{-1/2} \rangle \geq (\langle t \rangle + x^2)^{-1/2} \tag{C1}$$

or

$$W_m(x) \geq (m+1+x^2)^{-1/2}. \tag{C2}$$

Since $(a^2 + b^2)^{1/2} \leq a + b$,

$$W_m(x) \geq [(m+1)^{1/2} + x^2]^{-1}. \tag{C3}$$

$$2. 0 \leq f_m \leq 2(m+1)^{1/2} (1 - \ln 2)$$

f_m is evidently positive [see (3.21) and (3.3)]. By (C1)

APPENDIX D

1. Upper and lower bounds for $\text{Tr}(P)$

A lower bound is

$$\text{Tr}(P) \geq \int_0^\infty e^{-2\alpha x} [(m+1)^{1/2} + x]^{-1} = e^{2\alpha(m+1)^{1/2}} \epsilon_1 [2\alpha(m+1)^{1/2}] \geq \epsilon_1 [2\alpha(m+1)^{1/2}], \tag{D1}$$

where $\epsilon_1(x)$ is the exponential integral. For the upper bound write

$$\begin{aligned} \text{Tr}(P) &= \int_0^1 W(x)e^{-2\alpha x} dx + \int_1^\infty \frac{e^{-2\alpha x}}{x} dx + \int_0^\infty e^{-2\alpha x} \left(W(x) - \frac{1}{x} \right) dx \\ &= \int_0^1 W(x) dx + \int_1^\infty \left(W(x) - \frac{1}{x} \right) dx + \epsilon_1(2\alpha) + \int_0^1 (e^{-2\alpha x} - 1)W(x) dx + \int_1^\infty (1 - e^{-2\alpha x}) \left(\frac{1}{x} - W(x) \right) dx \\ &\leq \ln 2 + \epsilon_1(2\alpha) + \ln[1 + (m+1)^{1/2}], \end{aligned} \quad (\text{D2})$$

where we have used the negativity of the fourth term, (3.6) and (3.7), and finally (C3) to bound the last integral.

2. Upper bound for $\text{Tr}(PQ)$

From (3.3) and (3.11)

$$\text{Tr}(PQ) \leq \int_0^\infty \frac{e^{-2\alpha x}}{x} dx \int_0^x \frac{dy}{y} (1 - e^{-2\alpha y}) = \frac{\pi^2}{12} \quad (\text{D3})$$

by (B1).

APPENDIX E

Truncated Coulomb

The binding α^2 of the ground state of

$$-\frac{d^2}{dx^2} - \frac{\lambda}{1+|x|} \quad (\text{E1})$$

is given by

$$\left. \frac{dW_\beta(x)}{dx} \right|_{x=2\alpha} = 0, \quad \beta = \frac{\lambda}{2\alpha}, \quad (\text{E2})$$

where^{15,16}

$$\begin{aligned} W_B(x) &= e^{-x/2} \left(-\frac{1}{\beta} + \sum_{n=1}^\infty \frac{(1-\beta)_n}{n!(n+1)!} A_n x^{n+1} \right) \\ &\quad + [\ln x + \psi(1-\beta) - \psi(1) - \psi(2)] \\ &\quad \times \sum_{n=0}^\infty \frac{(1-\beta)_n}{n!(n+1)!} x^{n+1}, \end{aligned} \quad (\text{E3})$$

where

$$(1-\beta)_n = (1-\beta)(2-\beta)\cdots(n-\beta), \quad (1-\beta)_0 = 1$$

$$A_n = \sum_{j=0}^{n-1} [j+1-\beta]^{-1} - (j+1)^{-1} - (j+2)^{-1}. \quad (\text{E4})$$

A weak coupling expansion gives

$$\alpha = \lambda \text{Tr}(P) + (\lambda^2/\alpha) \text{Tr}(PQ) + \cdots, \quad (\text{E5})$$

where

$$\text{Tr}(P) = e^{2\alpha} \epsilon_1(2\alpha), \quad (\text{E6})$$

$$\text{Tr}(PQ) = \frac{1}{12} \pi^2 - \alpha \ln^2(2\alpha) + O(\alpha).$$

In Table IV a comparison is being made between the exact (E2) and (E5)–(E6) for values of λ corresponding [Eq. (2.3)] to $B=100, 200, 283, 500,$ and $1000.$
