

Gauging Quantum States: From Global to Local Symmetries in Many-Body Systems

We present an operational procedure to transform global symmetries into local symmetries at the level of individual quantum states, as opposed to typical gauging prescriptions for Hamiltonians or Lagrangians. We then construct a compatible gauging map for operators, which preserves locality and reproduces the minimal coupling scheme for simple operators. By combining this construction with the formalism of projected entangled-pair states (PEPS), we can show that an injective PEPS for the matter fields is gauged into a \mathbf{G} -injective PEPS for the combined gauge-matter system, which potentially has topological order. We derive the corresponding parent Hamiltonian, which is a frustration-free gauge-theory Hamiltonian closely related to the Kogut-Susskind Hamiltonian at zero coupling constant. We can then introduce gauge dynamics at finite values of the coupling constant by applying a local filtering operation. This scheme results in a low-parameter family of gauge-invariant states of which we can accurately probe the phase diagram, as we illustrate by studying a \mathbb{Z}_2 gauge theory with Higgs matter.

The fascinating subject of gauge theories is omnipresent throughout many-body physics. The gauge principle, which states that the fundamental interactions of nature originate from gauging global symmetries of the free theory, is one of the cornerstones of the standard model, but quantized gauge fields also emerge as effective degrees of freedom in several models for strongly correlated condensed matter, alongside other effective interactions. Historically, the concept of gauging, i.e., transforming a global symmetry into a local symmetry, is based on a Lagrangian or Hamiltonian description of the system where operators of the original (matter) theory are transformed into gauged operators using the “minimal coupling rule,” which is not always unambiguous [1]. Indeed, while there is a unique way to ungauged a theory (by setting the gauge fields and gauge coupling constant equal to zero), the reverse process is not unique as new degrees of freedom are introduced and the Hilbert space is enlarged.

The concept of gauging is, however, not strictly tied to any specific dynamics of the matter fields. This manuscript therefore explores how to gauge global symmetries at the level of individual quantum many-body states, independent of any prescribed Hamiltonian or Lagrangian. We thereto consider the Hilbert space $\mathbb{H}^{(m)}$ of a quantum many-body

system living on the vertices of a graph (the matter) and which has a global action of a group \mathbf{G} defined. We then introduce other degrees of freedom (the gauge field) by enlarging the Hilbert space to $\mathbb{H}^{(g,m)}$ and define a map $G: \mathbb{H}^{(m)} \rightarrow \mathbb{H}^{(g,m)}$ that explicitly transforms every matter state $|\psi\rangle$ that is invariant under the global action of \mathbf{G} to a corresponding gauge-matter state $|\Psi\rangle = G|\psi\rangle$ that is invariant under local symmetry actions of \mathbf{G} . Only thereafter do we introduce an associated gauging map \mathcal{G} for operators O , such that $GO|\psi\rangle = \mathcal{G}[O]G|\psi\rangle$ and local matter operators are mapped to local gauge-matter operators. This map reproduces the well-known result for simple operators such as hopping interactions or correlation functions but also produces unambiguous, operationally defined results for more complex operators involving, e.g., plaquette interactions for the matter fields.

To this date, the most accurate description of the strongly coupled, nonperturbative behavior of quantum gauge theories comes from Monte Carlo sampling of the path integral corresponding to Wilson’s lattice-gauge-theory formulation [2]. The Hamiltonian formulation of Wilson’s lattice gauge theory, originally developed by Kogut and Susskind [3] (but see also Refs. [4–6]), has been investigated in the context of approximate wave-function *Ansätze* [7–10] and is receiving a renewed interest in the context of cold-atom simulators [11–14] and tensor-network approaches [15–23]. The representation of quantum many-body states as tensor networks [24,25] originates from White’s successful density-matrix renormalization group [26] and is now well established in the context of one-dimensional

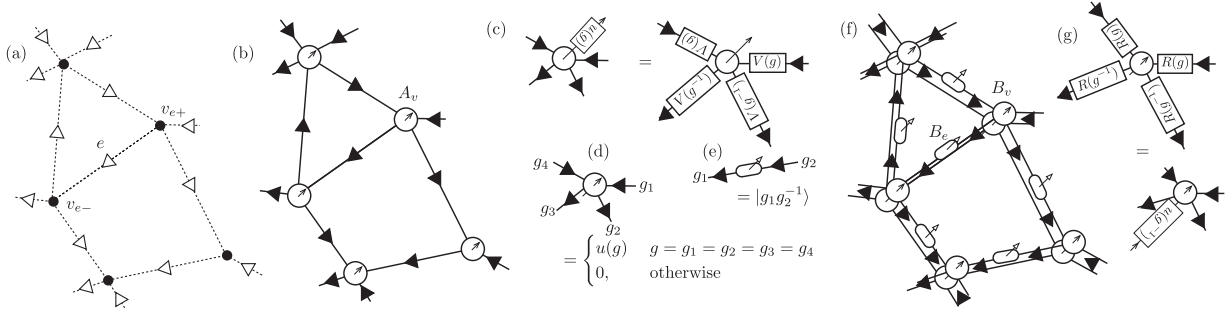


FIG. 1. (a) Definition of the graph Λ with vertices v and oriented edges e . (b) Construction of the PEPS $|\psi(A)\rangle$ from tensors A_v associated with the vertices v and with virtual bonds along the edges e and physical indices depicted as arrows pointing out of the center of every tensor. (c) Symmetry of a PEPS tensor to ensure global symmetry of the state $|\psi(A)\rangle$ under the group action U_g . (d) Definition of the tensor X_v used in the construction of the projector P onto the gauge-invariant subspace. (e) Result of acting with the tensor X_e on the physical input state $|1\rangle$, which is the only case we need throughout this manuscript. (f) PEPS $|\Psi(B)\rangle$ with vertex tensors B_v and edge tensors B_e obtained from acting with P on $|\psi(A)\rangle \otimes |1\rangle_e$. (g) Symmetry property of the tensor X_v .

quantum chains. However, recent results for the tensor-network description of higher-dimensional quantum systems [27] (including fermions [28–32]), quantum chemistry models [33–35], and even quantum field theories [36,37] look equally promising. In addition, the theoretical underpinning of tensor-network states in terms of the area law of entanglement entropy [38,39] makes them suitable for theoretical results as profound as the complete classification of gapped quantum phases [40,41]. The unifying theme in these studies does indeed correspond to a shift in focus from a Hamiltonian or Lagrangian description of the system toward a description in terms of the universal properties of the quantum (ground) state itself.

Following some early results [15,16], the application of tensor-network states to systems with gauge symmetry has recently seen a revived interest. Aside from some extremely accurate results for the Schwinger model [18–20], there have been first explorations with two-dimensional pure gauge theory [17] and theoretical formulations of classes of tensor-network states with explicit gauge invariance [21–23,42]. In this manuscript, we also combine our gauging construction with the formalism of projected entangled-pair states [27] (PEPS). We prove that an injective PEPS [43] with global symmetry \mathbf{G} is gauged into a \mathbf{G} -injective PEPS [44] (and refer to the Supplemental Material for a summary of these concepts [45]), which reestablishes the close relation between deconfinement and topological order in the case of discrete groups [46,47] or compact groups broken down to discrete subgroups [48–50]. We explicitly derive a parent Hamiltonian of the gauged PEPS, which resembles the Kogut-Susskind Hamiltonian at zero coupling. We discuss a well-known approach for introducing gauge dynamics at nonzero coupling constant and apply this prescription to obtain a low-parameter family of gauge-invariant tensor-network states that allows for accurate computation of expectation values. We use this strategy to study the phase diagram of a \mathbb{Z}_2 gauge theory with Higgs matter.

Throughout this manuscript, we consider a lattice or, more generally, a graph Λ with quantum degrees of freedom living on the vertices v , to which we henceforth refer as the matter fields. With every vertex $v \in \Lambda$, there is an associated Hilbert space \mathbb{H}_v , such that the total quantum state of the matter fields lives in the Hilbert space $\mathbb{H}_\Lambda^{(m)} = \otimes_{v \in \Lambda} \mathbb{H}_v$. We furthermore decorate Λ with oriented edges e as in Fig. 1(a). With a slight abuse of notation, we denote the edges in Λ as $e \in \Lambda$, where the only difference with the vertices $v \in \Lambda$ is in the chosen character. For every vertex v , we denote E_v^+ as the set of outgoing edges and E_v^- as the set of incoming edges. Correspondingly, we define $v_{e\pm}$ as that vertex for which $e \in E_v^\pm$, such that edge e points from v_{e+} to v_{e-} .

We start from a quantum many-body state $|\psi\rangle \in \mathbb{H}^{(m)}$ for the matter fields, which is invariant under the global action $U_\Lambda(g) = \otimes_{v \in \Lambda} U_v(g)$ of elements g in a finite or compact symmetry group \mathbf{G} , i.e., $U_\Lambda(g)|\psi\rangle = |\psi\rangle$. Here, $U_v(g)$ corresponds to a unitary representation of \mathbf{G} on the local Hilbert space \mathbb{H}_v of site v . In order to transform this state into a new state that is invariant under a local action of \mathbf{G} , we introduce new degrees of freedom, the gauge fields. We thereto define on every edge e of the graph Λ a new physical Hilbert space $\mathbb{H}_e = \mathbb{C}[\mathbf{G}]$ [51], spanned by the “position” basis $\{|g\rangle\}_{g \in \mathbf{G}}$. The left and right group actions of \mathbf{G} on \mathbb{H}_e are given by

$$L_e(h)|g\rangle_e = |hg\rangle_e, \quad R_e(h)|g\rangle_e = |gh^{-1}\rangle_e. \quad (1)$$

We denote the total gauge-field Hilbert space as $\mathbb{H}_\Lambda^{(g)} = \otimes_{e \in \Lambda} \mathbb{H}_e$ and the combined gauge-matter Hilbert space as $\mathbb{H}_\Lambda^{(g,m)} = \mathbb{H}_\Lambda^{(g)} \otimes \mathbb{H}_\Lambda^{(m)}$. A local gauge transformation with group element g on vertex v corresponds to the unitary operator $U_v(g) \otimes_{e \in E_v^+} R_e(g) \otimes_{e' \in E_v^-} L_{e'}(g)$. Group averaging using the Haar measure [52] can then be used to build a local projector P_v onto the invariant subspace, i.e., the states satisfying “Gauss law” at vertex v ,

$$P_v = \int dg_v U_v(g_v) \otimes_{e \in E_v^+} R_e(g_v) \otimes_{e' \in E_v^-} L_{e'}(g_v). \quad (2)$$

Note that $[P_v, P_{v'}] = 0$ thanks to $[L_e(g), R_e(h)] = 0$, so that the projector onto the gauge-invariant subspace of a region Γ is defined as $P_\Gamma = \prod_{v \in \Gamma} P_v$. In particular, $P = P_\Lambda$ is the projector onto the gauge-invariant subspace of $\mathbb{H}_\Lambda^{(g,m)}$, corresponding to the physical Hilbert space $\mathbb{H}_\Lambda^{(\text{phys})}$.

With these ingredients, we now present our prescription for gauging quantum states. It is given by the linear map $G: \mathbb{H}_\Lambda^{(m)} \rightarrow \mathbb{H}_\Lambda^{(\text{phys})}$ that acts on states $|\psi\rangle \in \mathbb{H}_\Lambda^{(m)}$ as $G|\psi\rangle = P|\psi\rangle \otimes_e |1\rangle_e$. We thus construct the direct product of the original state $|\psi\rangle$ for the matter field with a state for the gauge field which is a product state of $|1\rangle_e$ on every edge e corresponding to the identity element $g = 1$ of the group. The result is then projected into the gauge-invariant subspace $\mathbb{H}_\Lambda^{(\text{phys})}$ by P . We can explicitly evaluate G and find

$$G|\psi\rangle = \prod_{v \in \Lambda} \int dg_v U_v(g_v) |\psi\rangle \otimes_e |g_{v_{e-}} g_{v_{e+}}^{-1}\rangle_e. \quad (3)$$

From this definition, it is clear that $GU(g) = G$, since a global transformation $g_v \rightarrow g_v g$ will not appear in the configuration of gauge fields on the edges, if every edge is connecting two vertices v_{e+} and v_{e-} . One can, in fact, check that $G^\dagger G = \int dg U_\Lambda(g)$ is the projector onto the trivial representation of the global symmetry group \mathbf{G} in $\mathbb{H}_\Lambda^{(m)}$. This identity implies that initial states $|\psi\rangle$ that transform under a nontrivial representation of the global symmetry \mathbf{G} are annihilated by the gauging process G , which is the mathematical equivalent of the well-known fact that one cannot have a total net charge in a gauge theory on a closed surface [53].

We now look for an associated operator map \mathcal{G} for gauging an arbitrary matter operator O , in such a way that $G(O|\psi\rangle) = \mathcal{G}[O]G|\psi\rangle$. Since $G^\dagger G|\psi\rangle = |\psi\rangle$, where $|\psi\rangle$ is assumed to be invariant under the global symmetry action, one could define $\mathcal{G}[O] = GOG^\dagger$. However, for an operator O with nontrivial support on a compact region Γ , the resulting gauged operator GOG^\dagger would have nontrivial support on the whole lattice; i.e., it would no longer be locally supported. We therefore want to construct a different gauging map \mathcal{G}_Γ that maps local matter operator to local gauge-matter operators. For any $\Gamma \subset \Lambda$ containing both vertices $v_{e\pm}$ of all of its edges, but not necessarily all edges of its vertices, we first introduce the operator map $\mathcal{P}_\Gamma: \mathbb{L}(\mathbb{H}_\Gamma^{(g,m)}) \rightarrow \mathbb{L}(\mathbb{H}_\Gamma^{(g,m)})$ as

$$\begin{aligned} \mathcal{P}_\Gamma[O] &= \int \prod_{v \in \Gamma} dg_v \left[\prod_{v \in \Gamma} U_v(g_v) \prod_{e \in \Gamma} L_e(g_{v_{e-}}) R_e(g_{v_{e+}}) \right] \\ &\times O \left[\prod_{v \in \Gamma} U_v(g_v) \prod_{e \in \Gamma} L_e(g_{v_{e-}}) R_e(g_{v_{e+}}) \right]^\dagger. \end{aligned}$$

Note that $\mathcal{P}_\Gamma[O]P_v = P_v \mathcal{P}_\Gamma[O]$ for any $v \in \Lambda$, so that \mathcal{P}_Γ produces gauge-invariant operators, even though it does not include an explicit projector onto the gauge-invariant subspace; i.e., it does not necessarily annihilate states that are not gauge invariant. In particular, $\mathcal{P}_\Gamma[1] = 1$. We can then also define the gauging map

$$\mathcal{G}_\Gamma: \mathbb{L}(\mathbb{H}_\Gamma^{(m)}) \rightarrow \mathbb{L}(\mathbb{H}_\Gamma^{(g,m)}): O \rightarrow \mathcal{P}_\Gamma[O \otimes_{e \in \Gamma} |1\rangle_e \langle 1|_e].$$

One can check that $\mathcal{G}_\Gamma[O]$ acts diagonally on the gauge degrees of freedom, in such a way that

$$\mathcal{G}_\Gamma[O] \otimes_{e \in \Gamma} |1\rangle_e = \otimes_{e \in \Gamma} |1\rangle_e \otimes \int dg U_\Gamma(g) O U_\Gamma(g)^\dagger.$$

Combining this property with $P_v \mathcal{G}_\Gamma[O] = \mathcal{G}_\Gamma[O]P_v$ for any $v \in \Lambda$, it is easy to show that this map indeed satisfies $G\mathcal{G}_\Gamma[O]|\psi\rangle = \mathcal{G}_\Gamma[O]G|\psi\rangle$ for symmetric operators ($[O, U_\Gamma(g)] = 0, \forall g \in \mathbf{G}$), where the support of the gauged operator $\mathcal{G}_\Gamma[O]$ is equivalent to the support of the original matter operator (but, of course, also contains the gauge degrees of freedom on the edges $e \in \Gamma$). In addition, this identity allows us to show easily that \mathcal{G}_Γ is invertible onto the space of symmetric operators using the expected prescription

$$\text{tr}_{(g)}[\mathcal{G}_\Gamma[O] \otimes_{e \in \Gamma} |1\rangle_e \langle 1|_e] = \int dg U_\Gamma(g) O U_\Gamma(g)^\dagger = O,$$

where $\text{tr}_{(g)}$ is a partial trace over the gauge degrees of freedom living at the edges $e \in \Gamma$.

The current gauging procedure generates a gauged state $|\Psi\rangle = G|\psi\rangle$ at a zero value of the gauge coupling constant; i.e., the gauge degrees of freedom are frozen so that there are no magnetic fluxes and the gauged theory produces equivalent expectation values as the original theory. To introduce gauge dynamics for nonzero values of the coupling constant, we could manually add the electric energy term to the Hamiltonian. However, since we are working at the level of quantum states, we follow a different approach. Instead, we apply the well-known local filtering operation [55–57]

$$|\Psi\rangle \rightarrow \prod_{e \in \Lambda} \exp\left(-\frac{\beta}{2} \mathcal{E}_e^2\right) |\Psi\rangle, \quad (4)$$

with \mathcal{E}_e the electric field operator on edge e . It is now easy to check that the “ungauging” process (set $\beta = 0$ and project the gauge fields on the links e in $G|\psi\rangle$ onto $|1\rangle_e$) results in $\int dg U_\Lambda(g) |\Psi\rangle = |\psi\rangle$, where the last equality only holds if the starting state were invariant under the symmetry action.

It turns out that this gauging procedure is very natural in the framework of PEPS. Let us hereto introduce the PEPS $|\psi(A)\rangle$ using tensors A_v associated with every vertex $v \in \Lambda$. These tensors act as a multilinear map from virtual vector spaces \mathbb{V}_e associated with the incoming edges $e \in E_v^-$ to the virtual vectors spaces $\mathbb{V}_{e'}$ associated with the outgoing edges $e' \in E_v^+$ and the physical Hilbert space \mathbb{H}_v .

We identify \mathbb{V}_e with \mathbb{C}^{D_e} , with D_e the bond dimension on edge e . By choosing a canonical basis in all vector spaces, we can write

$$A_v = \sum_{s, \{\alpha_{e'}\}, \{\beta_e\}} (A_v)_{\{\alpha_{e'}\}, \{\beta_e\}}^s |s\rangle_{e' \in E_v^+} \otimes |\alpha_{e'}\rangle_{e \in E_v^-}. \quad (5)$$

The physical state $|\psi(A)\rangle$ is obtained by contracting the corresponding kets and bras of all virtual spaces. This construction is illustrated in Fig. 1(b). We now assume that the PEPS tensors A_v satisfy the generic property of injectivity [43], meaning that there exists a finite region $\Gamma \subset \Lambda$ such that the map from virtual boundary $\mathbb{V}_{\partial\Gamma} = \otimes_{e \in \partial\Gamma} \mathbb{V}_e$ to physical bulk $\mathbb{H}_\Gamma^{(m)} = \otimes_{v \in \Gamma} \mathbb{H}_v$ is injective. This property guarantees that the PEPS is “well behaved,” e.g., that it is the unique ground state of a local parent Hamiltonian. If an injective PEPS $|\psi(A)\rangle$ is invariant under the global action $U_\Lambda(g)$ for $g \in \mathbf{G}$, then it was proven in Ref. [58] that there must exist (projective) representations V_e of \mathbf{G} on the virtual spaces \mathbb{V}_e such that A_v acts as an intertwiner

$$A_v \left[\otimes_{e' \in E_v^-} V_{e'}(g) \right] = U_v(g) \left[\otimes_{e \in E_v^+} V_e(g) \right] A_v. \quad (6)$$

A slightly different form of this equation is presented in Fig. 1(c). While the representations V_e are not required to be unitary, we can, in principle, perform a “gauge” transformation [59] on the PEPS tensors to transform any finite-dimensional representation to a unitary representation if \mathbf{G} is a compact group.

The projector onto the gauge-invariant subspace of $\mathbb{H}_\Lambda^{(g,m)}$ also has a simple tensor-network description by introducing virtual spaces $\mathbb{V}_{e'} \equiv \mathbb{C}[\mathbf{G}]$ on every edge e and contracting all virtual bonds of vertex tensors X_v : $\mathbb{H}_v \otimes_{e \in E_v^-} \mathbb{V}_{e'} \rightarrow \mathbb{H}_v \otimes_{e \in E_v^+} \mathbb{V}_{e'}$ given by

$$X_v = \int dg U_v(g) \otimes_{e' \in E_v^+} |g\rangle_{e'} \otimes_{e \in E_v^-} \langle g|_e, \quad (7)$$

as sketched in Fig 1(d), and edge tensors X_e : $\mathbb{H}_e \otimes \mathbb{V}_{e'} \rightarrow \mathbb{H}_e \otimes \mathbb{V}_{e'}$ given by

$$X_e = \int dg_- dg_+ L_e(g_-) R_e(g_+) \otimes |g_-\rangle \langle g_+|. \quad (8)$$

For the case of continuous groups, the virtual dimensions of this tensor network are infinite and this representation is not amenable to numerical computations. Similar constructions of P appeared in the context of spin networks [60] and recently in the context of tensor networks [21,22], where it was also discussed how to compress the bond dimension to finite values.

Applying this gauging procedure G to the symmetric PEPS $|\psi(A)\rangle \in \mathbb{H}_\Lambda^{(m)}$, whose tensors A satisfy Eq. (6),

results in a new PEPS with virtual spaces given by $\mathbb{W}_e = \mathbb{V}_e \otimes \mathbb{V}'_e$. Indeed, we can write the new state $G|\psi(A)\rangle$ as a PEPS $|\Psi(B)\rangle$ sketched in Fig. 1(g) with vertex tensors

$$B_v = \int dg U_v(g) A_v \otimes_{e' \in E_v^+} |g\rangle_{e'} \otimes_{e \in E_v^-} \langle g|_e \quad (9)$$

and edge tensors given by

$$B_e = \int dg_+ dg_- |g_- g_+^{-1}\rangle \otimes \mathbb{1}_{D_e} \otimes |g_-\rangle \langle g_+|, \quad (10)$$

where the first ket corresponds to the physical state, the second factor to the action on \mathbb{V}_e , and the last factor to the action on the \mathbb{V}'_e . Using the intertwining property of A_v in Eq. (6) or Fig. 1(c) and the symmetry property of X_v sketched in Fig. 1(g), one can check that

$$\left[\otimes_{e' \in E_v^+} V_{e'}(g^{-1}) \otimes R'_{e'}(g^{-1}) \right] B_v \left[\otimes_{e \in E_v^-} V_e(g) \otimes R'_e(g) \right] = B_v,$$

where all factors act on the virtual level $\mathbb{W}_e = \mathbb{V}_e \otimes \mathbb{V}'_e$. In particular, $R'_e(g)$ corresponds to the right group action of \mathbf{G} on the virtual space \mathbb{V}'_e . We similarly have that

$$[V_e(g^{-1}) \otimes R'_e(g^{-1})] B_e [V_e(g) \otimes R'_e(g)] = B_e.$$

These two equations imply that the resulting PEPS cannot be injective, but below we prove it to be \mathbf{G} injective [44] instead. This property means that the map from virtual boundary to physical bulk is only invertible up to the action of group \mathbf{G} —whose representation on $\mathbb{W}_e = \mathbb{V}_e \otimes \mathbb{V}'_e$ is here given by $V_e \otimes R'_e$ —and is intricately related to topological order. More specifically, for a discrete group \mathbf{G} , the property of \mathbf{G} injectivity allows for the presence of anyonic excitations, although they could, of course, be confined or condensed, depending on the matter interactions and the gauge coupling constant. We refer to the Supplemental Material for additional details [45].

For the proof, we consider a region Γ on which the PEPS tensors act as an injective map. The range of this map is denoted as $\mathbb{A} \subset \mathbb{H}_\Gamma^{(m)}$ with $\dim \mathbb{A} = \dim \mathbb{V}_{\partial\Gamma}$ and corresponds to the support of the reduced density matrix of $|\psi(A)\rangle$ in Γ . Let $\{|\phi_i\rangle, i = 1, \dots, \dim \mathbb{A}\}$ be an orthonormal basis for this subspace, where every $|\phi_i\rangle$ is obtained from a unique state $|\tilde{\phi}_i\rangle \in \mathbb{V}_{\partial\Gamma}$ on the virtual boundary. A frustration-free parent Hamiltonian can be constructed from terms $h_\Gamma^{(m)} = 1 - \sum_i |\phi_i\rangle \langle \phi_i|$, i.e., the projector onto the orthogonal complement of \mathbb{A} . The symmetry under G follows from the fact $U_\Gamma(g)|\phi_i\rangle$ gives rise to a boundary vector $V_{\partial\Gamma}|\tilde{\phi}_i\rangle$, where $V_{\partial\Gamma}$ is the tensor product representation of the different V_e representations on the virtual boundary $\mathbb{V}_{\partial\Gamma}$. Since the boundary vectors $|\tilde{\phi}_j\rangle$

form a complete basis for the virtual boundary space $\mathbb{V}_{\partial\Gamma}$, we can write $V_{\partial\Gamma}|\tilde{\phi}_i\rangle = \sum_j u_{j,i}(g)|\tilde{\phi}_j\rangle$ and thus $U_\Gamma(g)|\phi_i\rangle = \sum_j u_{j,i}(g)|\phi_j\rangle$, where $u(g)$ has to be a unitary representation. Consequently, $h_\Gamma^{(m)}$ is invariant under the symmetry action.

For the gauged PEPS with tensors B , we choose Γ such that it excludes the physical spaces of the gauge fields on the edges $e \in \partial\Gamma$. We denote by Γ° the set of vertices in the interior of Γ , i.e., those vertices for which all edges and neighboring vertices are also contained in Γ . The vertices in the set $\Delta\Gamma = \Gamma \setminus \Gamma^\circ$ are on the (inside) boundary and have one edge $e \in \partial\Gamma$ [61]. If we now define the state $|\tilde{\Phi}_{i,\{g_v\}}\rangle = |\tilde{\phi}_i\rangle \otimes |g_{v_e}\rangle_e$ on the boundary $\mathbb{W}_{\partial\Gamma} = \otimes_{e \in \partial\Gamma} \mathbb{V}_e \otimes \mathbb{V}'_e$, where every edge e has a one-to-one correspondence with a vertex $v_e \in \Delta\Gamma$, the resulting state in the bulk $\mathbb{H}_\Gamma^{(g,m)}$ is given by

$$\begin{aligned} |\tilde{\Phi}_{i,\{g_v\}}\rangle &= \prod_{v \in \Delta\Gamma} U_v(g_v) \otimes_{e' \in E_v^+ \cap \Gamma} R_{e'}(g_v) \otimes_{e \in E_v^- \cap \Gamma} L_e(g_v) \\ &\times \prod_{v' \in \Gamma^\circ} P_{v'} |\phi_i\rangle \otimes_{e \in \Gamma} |1\rangle_e. \end{aligned}$$

One can show that $\langle \tilde{\Phi}_{i,\{g_v\}} | \tilde{\Phi}_{i',\{g_{v'}\}} \rangle = 0$ if there is no $g \in \mathbf{G}$ such that $\{g_{v'}\} = \{g_v g\}$, because the edges along the boundary, between two vertices in $\Delta\Gamma$, allow us to resolve the elements g_v up to the global transformation $g_v \rightarrow g_v g$. Having resolved g_v up to a factor g , the edges connecting $\Delta\Gamma$ to Γ° will act as a rough boundary, so that the inner product of the edge degrees of freedom will force all interior gauge transformations in ket and bra to be equal up to the global transformation g , resulting in

$$\begin{aligned} \langle \tilde{\Phi}_{i,\{g_v\}} | \tilde{\Phi}_{i',\{g_{v'}\}} \rangle &= \langle \phi_i | U_\Gamma(g) | \phi_{i'} \rangle \\ &= u_{i,i'}(g). \end{aligned}$$

Hence, the preimage of every bulk state $|\tilde{\Phi}_{i,\{g_v\}}\rangle$ is the set of states

$$\left\{ \otimes_{e \in \partial\Gamma} V_e(g) \otimes R'_e(g) | \tilde{\Phi}_{i,\{g_v\}} \rangle, \quad \forall g \in \mathbf{G} \right\},$$

in line with the concept of \mathbf{G} injectivity [44]. Even though the set of $\{|\tilde{\Phi}_{i,\{g_v\}}\rangle, \forall i, \forall g_v \in \mathbf{G}, \forall v \in \Delta\Gamma\}$ is overcomplete, we can still check that

$$h_\Gamma^{(g,m)} = 1 - \sum_i \int \prod_{v \in \Delta\Gamma} dg_v |\tilde{\Phi}_{i,\{g_v\}}\rangle \langle \tilde{\Phi}_{i,\{g_v\}}|$$

is a projector that annihilates the PEPS $|\Psi(B)\rangle$. Let us now try to rewrite this parent Hamiltonian using the operator gauging map \mathcal{G}_Γ . Note that

$$\sum_i \int \prod_{v \in \Delta\Gamma} dg_v |\tilde{\Phi}_{i,\{g_v\}}\rangle \langle \tilde{\Phi}_{i,\{g_v\}}| \neq \mathcal{G}_\Gamma \left[\sum_i |\phi_i\rangle \langle \phi_i| \right]$$

since the left-hand side contains two independent integrations for every interior vertex $v \in \Gamma^\circ$. Instead, we find $1 - h_\Gamma^{(g,m)} = \mathcal{G}_\Gamma[1 - h_\Gamma^{(m)}] \prod_{v \in \Gamma^\circ} P_v$ so that $h_\Gamma^{(g,m)}$ contains an explicit energy penalty for all non-gauge-invariant states. Since the physical Hilbert space $\mathbb{H}_\Gamma^{(\text{phys})}$ of a gauge theory is restricted to gauge-invariant states satisfying the Gauss-law constraint on every vertex, we can safely omit this additional factor and instead write

$$h_\Gamma^{(g,m)} = \mathcal{G}_\Gamma[h_\Gamma^{(m)}] + (1 - \mathcal{P}_\Gamma[\otimes_{e \in \Gamma} |1\rangle_e \langle 1|_e]). \quad (11)$$

We can recognize the first term as the gauged-matter Hamiltonian, whereas the second term is a pure gauge term. One can verify that it acts as a projector giving an energy penalty 1 to states with nonzero magnetic flux through any plaquette contained in Γ , which has to contain at least a single plaquette for the injectivity construction. Hence, for a single plaquette p , we can then write the second term as

$$1 - \int \prod_{e \in \partial p} dg_e |g_e\rangle_e \langle g_e|_e \chi^{(\text{reg})} \left(\prod_e g_e \right), \quad (12)$$

with $\chi^{(\text{reg})}(g) = \delta(g - 1)$ the character of the regular representation, where the product in its argument is ordered in the way the edges e appear along the boundary ∂p of the plaquette p , and all edges are assumed to be oriented similarly. This term corresponds exactly to the magnetic term of the quantum double models [46]. The typical magnetic term from the Kogut-Susskind lattice gauge Hamiltonian would replace $\chi^{(\text{reg})}$ with $\text{Re}\chi^{(l)}$, with l the fundamental representation in the case of a Lie group \mathbf{G} , but has the same ground-state subspace. Indeed, one can check that throughout our gauging construction, by initializing the gauge fields in the $|1\rangle$ configuration, we are effectively working at zero coupling constant for the gauge field and the magnetic energy term is automatically minimized.

Finally, the filtering operation in Eq. (4) can be applied to the PEPS without increasing the bond dimension or changing the \mathbf{G} -injectivity property. If $H^{(g,m)}$ is a frustration-free Hamiltonian with terms $h^{(g,m)}$ that annihilate the ground state, then the filtered PEPS is the ground state of a parent Hamiltonian built of terms

$$e^{(\beta/2) \sum_{e \in \Gamma} \mathcal{E}_e^2} h_\Gamma^{(g,m)} e^{(\beta/2) \sum_{e \in \Gamma} \mathcal{E}_e^2} = h_\Gamma^{(g,m)} + \beta \sum_{e \in \Gamma} \mathcal{E}_e^2 + \dots,$$

where the terms in the ellipses can be expected to become irrelevant under renormalization for small β , as they correspond to higher-dimensional operators in the continuum theory.

We now apply this gauging procedure for quantum states and operators to a number of examples. Consider as a first consistency check a nearest-neighbor pair of vertices $\Gamma = \{v_-, v_+\}$ with corresponding edge $e = (v_-, v_+)$. Let O^i be

a vector of operators such that $U(g)O^iU(g)^\dagger = \phi^{j,i}(g)O^j$ with ϕ some unitary representation of \mathbf{G} . Consider $O = \sum_i O_{v_-}^i O_{v_+}^{i\dagger}$. We obtain $\mathcal{G}_\Gamma[O] = \sum_{j,k} O_{v_-}^j \Phi_e^{j,k} O_{v_+}^{k\dagger}$, where $\Phi^{j,k}$ is given by

$$\Phi^{j,k} = \int dg \phi^{j,k}(g) |g\rangle \langle g|;$$

i.e., it is the operator that extracts the (j, k) element of the representation ϕ . We thus recover the minimal coupling rule for, e.g., a hopping term. This example trivially generalizes to the case where Γ contains a path between two distant vertices, as would be the case for a correlation function. The map \mathcal{G}_Γ then creates a gauge-invariant correlation function by inserting a Wilson line along the path. The choice of path will be irrelevant as long as the state is an exact ground state of the plaquette operators, i.e., as long as there are no fluxes created by, e.g., a finite value of the gauge coupling constant. For more complex matter Hamiltonians with, for example, plaquette interactions, one can check that our prescription exactly reproduces the gauging construction used in Ref. [62] to establish the relation between symmetry-protected topological order [63] and the twisted quantum double models [64]. In Ref. [65], the corresponding effect is investigated at the level of the PEPS, which, after applying the gauging prescription here developed, acquires the property of twisted \mathbf{G} injectivity [66] or an even more general notion of injectivity in terms of matrix product operators [67].

As a more elaborate example, we now consider the phase diagram of a gauge theory with Higgs matter, i.e., scalar bosonic matter transforming nontrivially under the gauge group, for the specific case of $\mathbf{G} = \mathbb{Z}_2 = \{1, -1\}$ in $(2+1)$ dimensions. Using a basis $|1\rangle, |-1\rangle$ for both \mathbb{H}_v and \mathbb{H}_e , we have $L_e(-1) = R_e(-1) = \tau^x$ and we also choose to have $U_v(-1) = \sigma^x$, with σ^x and τ^x the Pauli operators for matter and gauge fields, respectively. We start from the ground state of the Ising model

$$H_I = \sum_v (1 - \sigma_v^x) + \beta_z \sum_e (1 - \sigma_{v_e^-}^z \sigma_{v_e^+}^z)$$

at $\beta_z = 0$, i.e., the state $|\psi_0\rangle = \prod_v |+\rangle_v$. Instead of turning on a finite β_z in the Hamiltonian, we again resort to applying a filtering operation $\prod_e e^{(\beta_z/4)\sigma_{v_e^-}^z \sigma_{v_e^+}^z}$. The resulting state $|\psi_{\beta_z}\rangle$ is a PEPS with bond dimension two and parent Hamiltonian [68]

$$H^{(m)} = \sum_v (e^{-(\beta_z/2)} \sum_{e \in E_v} \sigma_{v_e^+}^z \sigma_{v_e^-}^z - \sigma_v^x),$$

where $E_v = E_v^+ \cup E_v^-$. $H^{(m)}$ in the equation above matches the Ising Hamiltonian H_I at lowest order in β_z . We now apply the gauging procedure $|\Psi_{\beta_z,0}\rangle = G|\psi_{\beta_z}\rangle$ and switch on an electric field $\mathcal{E}^2 = (1 - \tau^x)/2$ with coupling constant β_x using local filtering, to obtain the state

$$|\Psi_{\beta_z,\beta_x}\rangle = \prod_e e^{(\beta_x/4)\tau_e^x} \prod_v P_v \prod_e |1\rangle_e e^{(\beta_z/4)\sigma_{v_e^-}^z \sigma_{v_e^+}^z} \prod_v |+\rangle_v,$$

with $P_v = (1 + \sigma_v^x \prod_{e \in E_v} \tau_e^x)/2$. This state can be written as a PEPS with bond dimension four. However, we can easily “disentangle” the matter fields by applying a controlled-NOT (CNOT) gate with the matter field as control and the gauge field as target for every pair of $(v, e \in E_v)$. Since all these gates commute, the latter constitutes a finite-depth quantum circuit that transforms the Gauss law $(P_v - 1)|\Psi\rangle = 0$ into $(\tilde{P}_v - 1)|\tilde{\Psi}\rangle = 0$, with $\tilde{P}_v = (1 + \sigma_v^x)/2$ and $|\tilde{\Psi}\rangle$ the transformed state. Hence, gauge invariance in this transformed frame requires all matter fields to be in the $|+\rangle_v$ state so that we are left with unconstrained degrees of freedom on the edges. Applying the CNOT transformation to $|\Psi_{\beta_z,\beta_x}\rangle$ results in the state

$$|\tilde{\Psi}_{\beta_z,\beta_x}\rangle = \prod_e e^{(\beta_x/4)\tau_e^x} e^{(\beta_z/4)\tau_e^z} |\Psi_{\text{TC}}\rangle \otimes |+\rangle_v,$$

with $|\Psi_{\text{TC}}\rangle$ the toric code ground state [46] for the edge degrees of freedom. This mapping is equivalent to the well-known correspondence between the normal \mathbb{Z}_2 gauge theory with matter, whose phase diagram was first considered by Fradkin and Shenker [69], and the toric code Hamiltonian with magnetic fields

$$H_{h_z,h_x} = H_{\text{TC}} - h_z \sum_e \tau_e^z - h_x \sum_e \tau_e^x \quad (13)$$

as studied in Refs. [70–72]. Note that the definition of the state $|\tilde{\Psi}_{\beta_z,\beta_x}\rangle$ depends on the order of applying the filtering in τ^z and in τ^x . Since the motivation for these filtering operations comes from the lowest order in β , at which level they do commute, we can also opt for a more symmetric definition

$$|\Psi'_{\beta_z,\beta_x}\rangle = \prod_e e^{(\beta_x \tau_e^x + \beta_z \tau_e^z/4)} |\Psi_{\text{TC}}\rangle \otimes |+\rangle_v.$$

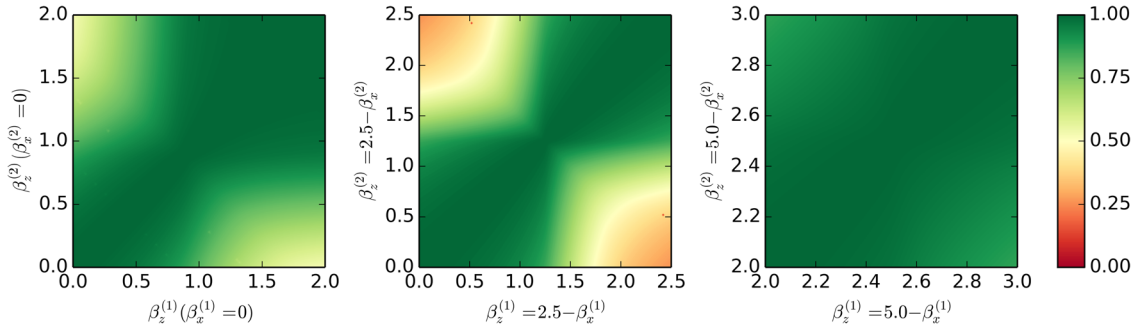


FIG. 3. Fidelity (per site) $|\langle \Psi_{\boldsymbol{\beta}^{(1)}} | \Psi_{\boldsymbol{\beta}^{(2)}} \rangle|^{1/N}$ between any two ground states with parameters $\boldsymbol{\beta}$ along the three different slices indicated in Fig. 2.

The PEPS representation of $|\Psi_{\text{TC}}\rangle$ has bond dimension two [68], which is not increased by the local filtering. We can probe the phase diagram on this \mathbb{Z}_2 gauge theory as function of $\vec{\beta} = (\beta_z, \beta_x)$ by studying the ground-state fidelities in Figs. 2 and 3. Fidelities are computed as described in Ref. [73]. The fidelities illustrate that our *Ansatz* qualitatively reproduces the phase diagram of H_{h_x,h_z} and describes the same gapped phases in weak- and strong-coupling limits. There is the deconfined phase with topological order around $\beta = \mathbf{0}$ and the trivial Higgs phase and confined phase, which are connected by a local unitary spin rotation at $\|\beta\| \rightarrow \infty$, where $|\Psi_{\beta_z,\beta_x}\rangle$ is just a product state of eigenvectors of $\beta_z \tau^z + \beta_x \tau^x$ corresponding to the largest eigenvalue. The critical behavior, however, is not exactly reproduced. It is known, for example, that the

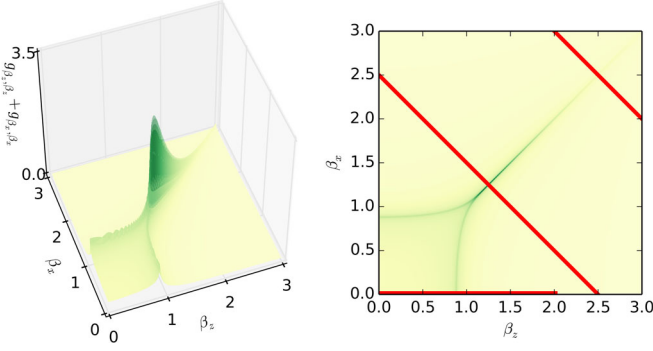

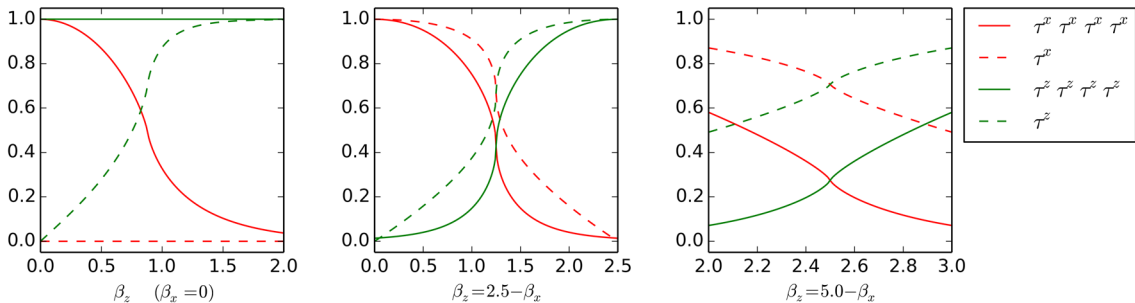


FIG. 4. Expectation values of the relevant Hamiltonian terms, i.e., τ^x and τ^z on the edges, $\tau^x \tau^x \tau^x$ around a vertex, and $\tau^z \tau^z \tau^z$ around a plaquette, along the three different slices indicated in Fig. 2.

FIG. 2. Trace of the metric $g(\boldsymbol{\beta})$ with $\boldsymbol{\beta} = (\beta_z, \beta_x)$, as obtained from the fidelity $|\langle \Psi_{\boldsymbol{\beta}} | \Psi_{\boldsymbol{\beta} + \delta\boldsymbol{\beta}} \rangle| = \exp(-N\delta\boldsymbol{\beta}^T g(\boldsymbol{\beta})\delta\boldsymbol{\beta})$, where N is the (infinite) number of sites, as defined in Ref. [80]. An analytic expression for g along the coordinate axes ($\beta_z = 0$ or $\beta_x = 0$) was obtained in Ref. [81]. The red lines in the right panel indicate the slices studied in Figs. 3 and 4.

topological phase transition from the deconfined to the trivial phase along the coordinate axis $\beta_z = 0$ (and by $\tau^x \leftrightarrow \tau^z$ duality also along the coordinate axis β_x) is in the 2D Ising universality class [57,74], whereas the corresponding phase transition of H_{h_x, h_z} is in the 3D Ising universality class. Also, we obtain a second-order phase transition along the duality line $\beta_x = \beta_z$ that does not seem to vanish until $\|\boldsymbol{\beta}\| = \infty$, even though the singularities in the fidelity (Figs. 2 and 3) and expectation values (Fig. 4)

very quickly become small. The corresponding transition of H_{h_x, h_z} is conjectured to be first order with a discontinuity in the expectation values of the star and plaquette operator and to end at a finite value of $\|\boldsymbol{\beta}\|$ [70–72]. In contrast, the state $|\Psi_{\beta_z, \beta_x}\rangle$ seems to have continuous expectation values but a diverging derivative along a slice passing through the phase transition at the duality line $\beta_x = \beta_z$ (Fig. 4). Note that one could also use the state $|\Psi_{\beta_z, \beta_x}\rangle$ or a slightly more general class as a variational *Ansatz* for the actual Hamiltonian, as was done for the case $\beta_z = 0$ in Ref. [75], which quickly led to accurate results. See also Ref. [76], where the state $|\Psi_{\beta_z, \beta_x}\rangle$ at the limiting values $\|\boldsymbol{\beta}\| = 0$ and $\|\boldsymbol{\beta}\| = \infty$ was used as a variational *Ansatz*, as well as other Hamiltonian studies using large coupling expansions [77,78]. A more detailed analysis of our results for \mathbb{Z}_2 and higher \mathbb{Z}_N groups is presented elsewhere [79].

In conclusion, we have proposed an operational procedure for gauging global symmetries at the level of individual quantum states. This procedure combines naturally with the framework of PEPS. When gauging an injective PEPS, we have shown how to obtain a \mathbf{G} -injective PEPS and we have derived a parent Hamiltonian, which automatically contains a projector gauge theory at zero coupling constant. By introducing gauge dynamics for nonzero values of the coupling constant using a local filtering operation, this construction

results in a low-parameter family of PEPS for which the phase diagram can accurately be probed, as we have illustrated by studying the phase diagram of a \mathbb{Z}_2 gauge theory with Higgs matter. Tensor networks are indeed promising candidates to avoid Feynman’s objections [82] regarding non-Gaussian states that allow us to efficiently compute expectation values [37]. Similar strategies are perfectly feasible for studying gauge theories with fermionic matter, using the framework of fermionic PEPS [28–32], or even gauge theories (with or without matter) in three spatial dimensions, since no variational optimization is required.
